Answer: Yes. However, expenditures relating to the EuropeWave project vary from quarter to quarter and receipt of funding from the EuropeWave Program lags behind expenditure.

Answer: Subsequent to the end of the quarter, the Company received the 2023 R&D Tax refund of \$620,703. The company continues to monitor its cash position and is confident that it can raise capital as and when required to fund normal business operations.

Answer: The Company expects to be able to continue its operations and meet its objectives as a going concern through the raising of capital and utilisation of funding provided under the EuropeWave Program.
